

5. - c. To develop analytical approach and technical skills in students for creative thinking.
 - d. To develop the sense of responsibility towards self, family and the society through the system of education and to develop leadership and management qualities in students.
 - e. To develop through education and to inculcate good moral, student ethics and sportsmanship and to provide financial assistance to the needy and meritorious students.
 - f. To identify and honor the passionate teachers for their service.

10. The First Managing Trustee shall be Mrs. Udhaya Banu and shall be the chairman to the Board of Trustees. In the event of any Vacancy arising in the said office, the board of Trustees shall elect one of their body to be the Chairman of the Board/Managing Trustee.
11. The Chairman of the Board, shall, if present preside over the meetings of the Board of Trustees. If the Chairman is not present within half an hour of the time for which the meeting has been convened, the members present shall elect one of their body present at the meeting to be the chairman of the meeting.

- e. Is requested unanimously by all the other Trustees to resign and a letter to this effect signed by all Trustees be delivered.
14. Any Individual who is a citizen of India and has attained the age of majority and of sound mind is eligible to become a Trustee.
15. On the arising of any vacancy or vacancies by death, resignation or any other cause in the office of Trustees the remaining Trustees shall elect by a resolution of the Board of Trustees any person they consider suitable to fill the said vacancy within two months.
16. On any vacancy arising in the office of the Chairman or Managing Trustee by afflux of time, resignation, death or any other cause the Board of Trustees shall appoint one of their body to the said office.
17. The Board of Trustees shall be entitled to act, exercise all their powers not withstanding any vacancy or vacancies in the Board. Provided that the total number of Trustees shall not any time be less than six.
18. All immovable properties acquired for the Trust shall be purchased in the name of the Trust and unless otherwise decided by the Board of Trustees in exercise of the power under Clause 21 below;
19. 20. The Board of Trustees shall have full control and management of all the affairs of the Trust and of the properties, assets and transactions of the Trust and without Prejudice to the generality of the foregoing, exercise any or all the following powers and discretion namely:-
- a. To allocate to each of the objects such portion of the funds as they deem fit.
 - b. To invest funds of the Trust in any of the modes prescribed by section 13 of the Income-tax Act.
 - i) In Trust Securities or in any manner authorized by law in force for the time being for the investment of Trust funds.
 - ii) By fixed deposits or other deposits with any Bank.
 - iii) In any manner authorized or Prescribed under sec.13 of Income-tax act.
 - iv) To purchase or acquire or by lease or in any other manner any immovable properties or interest in immovable properties or immovable properties of any kind considered by the Trustees to be useful for the objects of the Trust.
 - c. To incur all the expenditure necessary or in their opinion useful for carrying out of the objects of the Trust.
 - d. To open one or more bank accounts for the Trust and in its name with any bank or Banks as the Trustees may deem fit and deposit monies of the Trust in such accounts and to give instructions to the Bankers as to persons entitled to operate thereon.

- h. To sell, lease or dispose of any immovable properties, assets and goods of the Trust for the objects of the Trust.
- i. To borrow for and behalf of the trust, any sums of money for any of the purposes of the Trust on such terms as to interest, security or otherwise as the Trustees may determine and to mortgage or charge any properties of the Trust as security for the same.
- j. To employ staff of all kinds necessary or useful for the carrying out the objects of the Trust.
- k. To Mortgage or charge any property or asset movable or immovable for the Trust or vested in trustees in favor of the Government or any Department thereof in Pursuance of the rules of the Government for the purpose solely of obtaining grants from the Government or any other Department thereof.


- n. The Trustees may frame Rules, by-laws, or Regulations as to the day to day administration of Management of the Trust and also regarding duties and responsibilities of the Trustees for carrying out the objects of the Trust and also regarding the appointment of committees and sub committees, their duties and obligations and all such other matters connected with or relevant to the Trust and its administration.
- o. The Trustees have powers to convert, call in, sell or otherwise dispose of or dispense with any of the investments, movable or immovable properties of the Trust and re-invest or change the nature of investment contained therein.
21. The Board shall have power to accept contributions in money or property either by way of addition of the Trust funds generally or for any one or more of the specified objects if the Trust in so far as they are not inconsistent with any of the provisions of this Trust and in either case such contributions shall be dealt with either as capital receipt or as income according to discretions of the donors but subject to the conditions that in the opinion of the trustees it must be conducive to the beneficial administration of the Trust.

25. The Trustees may nominate one or more persons either by name or otherwise to be in custody of any of the assets of the Trust to HOLD properties and assets of the Trust in his or their names for and on behalf of the Trust and to execute all documents, contracts and deeds for and on behalf of the Trust. The Trustees shall specify and nominate one or more persons who shall be entitled to institute, conduct or defend all suits and legal proceedings for and on behalf of the Trust and to receive service of summons and processes for and on




28. The Trust may contribute for religious purposes/institutions a sum not exceeding 5% or such other percentage as permitted under the Income-Tax Act, 1961 of its income during any financial year.
29. Subject as aforesaid the Trustees shall have powers from time to time to make and alter or amend the rules and regulations made with regard to the conduct of the Business and all matters in respect of which any power or duty is hereby invested in them as they think proper.
30. The Trust does not own any immovable property as on this date.
31. This Trust shall be irrevocable.
32. The above Trustees have each contributed a sum of Rs.1000 /- in all 6000/- to be the nucleus/seed or as the initial corpus fund of the Trust to start with and hold the same for the objects stated above.
