

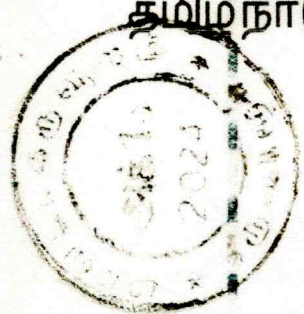

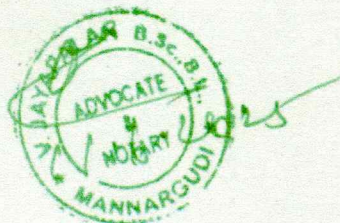

6. That the Principal and Correspondent/Manager of the school have individually reviewed and understood the provisions laid out in the **CBSE Affiliation and Examination Byelaws**, as well as the circulars issued by the CBSE from time to time. The school undertakes to abide by these regulations and all other legal directives.
7. That the school shall fully comply with all statutory obligations including but not limited to **EPF, ESI, and Labour Laws**, with respect to its staff and operations.
8. That the school shall ensure timely procurement or renewal of **Building Safety, Fire Safety, Water Safety, and Health & Hygiene** certificates from the competent municipal or state authorities as per applicable norms.
9. That the school shall provide the **necessary infrastructure** in accordance with prescribed norms **prior to commencement of classes**.
10. That the school shall engage a **sufficient number of qualified teachers** as per CBSE affiliation byelaws **before starting classes**.
